President Paul Lewis called meeting to order at 6:30pm, followed by Pledge of Allegiance, moment of silence for George Crump and Prayer.

#### **Commission Meeting:**

County Coordinator will Begin taking delinquent accounts to the magistrate, beginning with the oldest cases first.

Jay Fansler is now the new County Commissioner representative

Nathan Kesner explains the Argo vehicle and purchase of additional equipment that might be necessary. HCEAA applied for a grant through Firehouse Subs and have been approved. Nathan will be getting quotes from different dealers. HCEAA be asking for donations from the community i.e. Grant County Mulch, American Woodmark or Pilgrim's for the trailer that will be needed to haul the Argo. It is a specialized piece of equipment and is the EMS version. The Argo will be available to the entire county for search and rescue but not for swift water.

Motion to accept the grant from Firehouse Subs made by Fran, Tim seconds.

Derek states they have purchased 2 iPads for \$500 Tablets for the Covid Testing. Once the testing is completed they can repurpose them and put them on the units.

Derek requests approval for the \$2.00 an hour stipend for the 2<sup>nd</sup> Crew through February

Motion to approve additional \$2.00 stipend for January and to extend to next meeting February 10<sup>th</sup> made by Doug, Tim seconds. Motion carries

Derek spoke to Wardensville in regards to the additional money for the Covid testing and they have requested the \$2000 for the purchase of Polo's, Jackets, etc.

Motion made by Fran to give a one-time payment of \$2000 to Wardensville for the purchase of Polo's, Jackets, etc., Ron second. Motion carries.

#### **Board Member and Employee Comments:**

From the training class that Wardensville completed, as far as they know none of the students have tested. There are no longer state test, all the test are National Registry.

Doug inquires about a response in reference to the letter that was sent to Wardensville. No response has been received. Derek states that the power lies within the board. It is our job to take care of it and the commission to pay for it. Doug feels there is no clue as to what is going on in Wardensville. If Wardensville were to dissolve and HCEAA were to take the area over, then HCEAA would receive the revenue from the calls. Derek states that they can do it if Fraley is willing and available to come over. They have no option with Virginia or Hampshire Co. Doug states he will vote to maintain the 2nd crew. Fran stands by Doug in regards to the lack of coverage at Company 1. Paul states that is something they will have to review with the budget in regards to the payroll.

#### **Public Comments:**

Jean ask how much should the HCEAA be getting reimbursed through the CARES Act. Derek doesn't have any idea as it was all lumped in together as a county. They are not sure if Rose has submitted the final amount. HCEAA has mostly submitted for reimbursement for payroll but has included the Papr's, P100's and UV lights.
